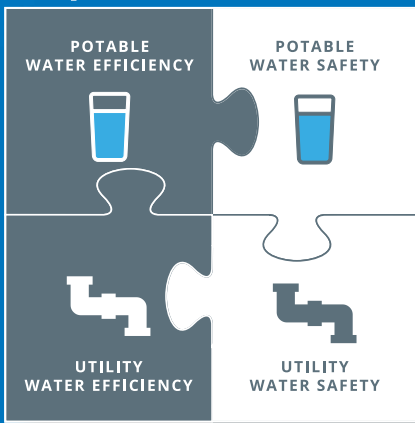

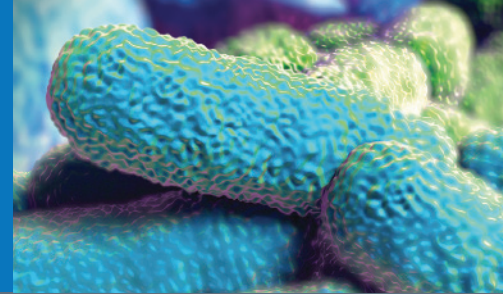

- PVT test products include the Phigenics patented TimeZero™ method, Next Day *Legionella* PCR™, and the ISO 117831 spread plate method.

Phigenics Analytical Services Laboratories are certified as proficient in the Environmental *Legionella* Isolation Techniques Evaluation (ELITE) program administered by the Centers for Disease Control and Prevention (CDC) for using the Phigenics Patented PVT Tests and the ISO 11731 spread plate method.

Phigenics is an EPA-NELAP certified laboratory for the analysis of drinking water and provides a wide range of other testing services for biohazards such as *Pseudomonas*, *Stenotrophomonas*, *Acinetobacter*, *Mycobacterium*, *Aspergillus* and *Fusarium*. Phigenics also provides complete testing services required by the Safe Drinking Water Act.
